Dear Winnebago Producer,


This registration form details the face-to-face training session that I have set up for private pesticide applicators who wish to become certified or re-certified in 2017.

All producers are charged \$30.00 for the training materials and the state certification. The additional \$8.00 charge is to cover the cost of a noon meal to be catered on that day. Producers can choose to pack their own lunch to eliminate the \$8.00 lunch charge.

All private applicators have the option to certify/re-certify through a self-study option. If you are thinking about becoming certified through this method, please give our office a call and we will walk you through the steps to register and take the exam.
