GROW 4-H... Leave a Legacy

Planned giving provides options and opportunities to include the Winnebago County 4-H program in your overall financial and estate plans. Gifts of any size will help “Grow 4-H” our youth opportunities.

Making a charitable gift to the 4-H Educational Endowment Fund is an important and very personal decision. When you make a charitable gift, you will not only be providing for the needs of the 4-H program today, but for years to come.

Gift Options

Several ways exist to make a tax-deductible charitable contribution or donation to honor a loved one. Let your attorney or financial advisor know you are considering a gift to the 4-H Educational Endowment Fund. They can assist you in determining what type of gift best suits your circumstances.

Memorials—Preserve the memory of a loved one by naming the 4-H Educational Endowment Fund as the recipient of donations given in their honor.

Bequests—Through your will or trust, you can designate a specific amount of your total estate to the 4-H Endowment Fund.

Gifts of Retirement Plans—Name the 4-H Educational Endowment Fund as beneficiary of a pension, 401K, IRA or other retirement plan

Charitable Gift Annuities—Annuities provide for a steady income from your charitable gift, while benefiting from tax advantages.

Gifts of Life Insurance—Name the 4-H Endowment as the primary or secondary beneficiary of a new or existing life insurance policy. After your lifetime, proceeds are used to add to the fund.

Charitable Remainder Trust—Make a tax-deductible gift to build the trust now and you’ll receive an income for a number of years or for life. The 4-H Endowment receives the “remainder” of the trust at death.

Charitable Lead Trust - Make a tax-deductible gift to open the trust now and the 4-H Endowment will receive annual payments from it. Your heirs receive the trust balance at your death.
